


# Member Impact Summary 2023

### MONICA TOGUCHI-RYAN

**HSFCU Experience:** HSFCU was the first bank I joined as an adult, back in college, and I have been

a member for almost 32 years. In 2002, as a Ph.D. candidate at the University of Oregon, I received an HSFCU Scholarship.

Education: Mililani High School; University of Hawai'i at Mānoa (BBA in Business Administration; Master's in Education). University of Oregon Ph.D. candidate in Counseling Psychology (I resigned from my program after seven years to take over Highway Inn when my father suffered a stroke)

In 2023, I was recognized as the 2023 US-SBA Women-Owned Business for Hawai'i.

Amidst various social, economic, and geopolitical uncertainties, I am committed to prioritizing our strategic objectives and financial stability.
